- 3. Treasurer's report (Sheri-Lee):
  - The Bank Reconciliation and Activity as of June 10, 2025 is attached to these minutes.
    - -The Parent Association account has a balance of \$14,444.64
    - -The current Casino Account funds are \$34,432.91
  - Motion to accept the financial documents by Devin; seconded by Anne. Financial minutes approved.
  - Sheri-Lee also walked through the 2025-2026 School Wish List, prepared by the administration. It totals \$34,101 and includes money for a variety of items such as residencies/ school experiences, school celebrations and bussing for field trips. It was noted that the school generally requests \$30,000-\$40,000 in funding each year, that the Parent Association provides. Without the funding, we would have less school experiences and families could be charged a fee for their student to participate. Sibbald is fortunate to have an active parents association.
